Jackson and McMahon honored as 2015 NYSUT Retirees of the Year

Donesa Jackson and Pete McMahon, who combined, represent more than seven decades of dedicated labor activism, were honored as New York State United Teachers' 2015 Retirees of the Year at the union's 43rd annual Representative Assembly in Buffalo.

McMahon, a science teacher for nearly 40 years at Red Hook High School and a longtime past president and vice president for the Red Hook Faculty Association, is also a staunch political activist, serving as the Mid-Hudson VOTE- COPE coordinator from 1981 until 2014, and a Political Action Committee member from the late 1980s until last year.

"Retirees' contributions to VOTE-COPE are extremely important not only for how they help NYSUT affect legislation, but because they also are a valuable link to the in-service local," said McMahon. "Without NYSUT a large number of the things that we consider to be a given would no longer be available to us."

As a retiree, McMahon remains active, serving his third term as a member of the NYSUT Retiree Advisory Committee and, for nearly the last decade, as Retiree Council 13 treasurer.

"I believe that retirees are a tremendously important resource," said McMahon. "We, as a union, would not be able to protect what we have, and continue to achieve our goals, without active retirees."

Teachers retiree Donesa L. Jackson, a former chapter leader for P.S. 89 and a part-time pension consultant, salary and licensing adviser at the UFT Bronx office, remains active in retirement, serving as the UFT's retiree leader in the Orlando, Fla., area of Orange and Seminole counties; on the Orlando Central Labor Council; regularly coordinating with the American Federation of Teachers/Florida Education Association locals on issues and campaigns; and establishing a local chapter of the Alliance for Retired Americans. ship, Jackson was a 2012 elected delegate to the Democratic National Convention.

"My union has done so much for me that I must give back," said Jackson. "And the way that I can give back is in the work that I do as a retiree for my union."

Quipped Jackson, "We have our hip replacements and our knee replacements, we have our walkers and our canes, but we are there!"

"The consistent support of members like Donesa, who've dedicated themselves to advancing the union movement, is an inspiration for us all," said Karen E. Magee, NYSUT president. "Donesa Jackson is a testament to the fact that today's active membership owes a large debt of gratitude to our retired members."

"Pete and Donesa's commitment to improving the lives of working families and to the labor movement is not limited to their professional lives — they continue to make that a focus of their life's work," added NYSUT Vice President Paul Pecorale. "Both represent the very best of our union."

Earned benefits focus of pre-RA retiree workshop

Defending earned-benefit programs such as Social Security, Medicare and public pensions, and raising awareness of the looming New York state constitutional convention vote in 2017, was the focus of a workshop for retiree leaders at the pre-RA Local and Retiree Council Presidents Conference. Paul Pecorale, NYSUT vice president, whose office handles retiree issues, welcomed participants, thanking them for "their advocacy and hard work."

Featuring Professor Eric Kingson, co-author with Nancy Altman, of the book *Social Security Works! Why Social Security Isn't Going Broke and How Expanding It will Help Us All*, the session dispelled the myth that Social Security is insolvent.

"Less than a penny is spent for every dollar that's paid out," said Kingson, the founding co-director of Social Security Works and co-chair of the Strengthen Social Security Campaign, a coalition of more than 300 national and state organizations, such as the national AFL-CIO. He urged retirees to "keep blocking destructive legislative proposals, and lobbying for the expansion of Social Security."

Steven Leberstein and Bill Friedheim of the retiree chapter of the Professional Staff Congress' Social Safety Net Working Group — which travels statewide educating about the value of earned-benefit programs — also spoke. PSC represents NYSUT members at CUNY colleges. Friedheim leads the retiree chapter and Leberstein and PSC retiree John Highland lead the safety net workgroup, created in 2010 in the wake of congressional attacks on earned benefit programs. "The social safety net is under attack," said Leberstein who urged retirees to educate in-service members about the risks of erosion to the programs.

Peter Savage, NYSUT legislative staffer, highlighted threats posed by the upcoming vote to hold, or not hold, a New York state constitutional convention. A vote on the measure will appear on the November 2017 state election ballot. Since the constitution protects fundamental rights such as guaranteed pension benefits and the right to unionize and bargain collectively, opening it carries great risk.

"Holding a convention could allow for sweeping change to the state constitution," said Savage, explaining that "literally everything is on the table" if voters vote in favor of holding a constitutional convention. Mobilizing to defeat the measure will be an important campaign in 2017, he said. 3. The retiree council president must sign and return the "Retiree Membership List Confidentiality and Nondisclosure Agreement" <u>and</u> their retiree council's resolution to NYSUT Retiree Services.

Judith Wishnia wins Higher Ed Member of the Year

Judith Wishnia's four decades of higher education unionism have been marked by one steady attribute: commitment to social justice.

Her selection as a NYSUT Higher Education Member of the Year honors the many ways her commitment has played out, as a labor historian; advocate for fair work conditions;

and a voice for women, the homeless and retirees.

The daughter of a union household, Wishnia was a longtime professor at the State University of New York at Stony Brook. In 1976, she joined United University Professions, NYSUT's affiliate representing academic faculty and staff at the State University of New York's state-operated campuses, where her contributions continue into retirement.

She is a former member of the UUP statewide executive board and negotiations team and the recipient of UUP's highest honor, the Nina Mitchell Award for Distinguished Service. She was instrumental in the creation of the NYSUT Retiree Council, which she chaired, and she served for a decade as the chair of UUP's Committee of Active Retiree Members. She has also served on the women's advisory and housing committees in Suffolk County.

"Judy Wishnia has exemplified higher education unionism, and she has been a strong, articulate voice for the underserved in our society," UUP President Fred Kowal said. "She's also been an outstanding example to a new generation of activists, as a unionist who believed in a lifetime of service."

Wishnia echoed those words when she talked about what it means to join a union.

"I really feel it's a lifelong commitment," she said. "You do it because unions are the vanguard of social justice. They're the ones that are protecting the working people of the country."

Florence McCue, NYSUT ED 51-53 at-large director, welcomed retirees and thanked them for their outstanding advocacy over the last few months at the NYSUT Retiree Contiguous ED 51-53 (At-Large) meeting at the 43rd annual NYSUT RA. "How many of you could have imagined having half your teacher evaluation based on student test scores?" said McCue. "We understand how unfair this is, and you have been making your voices heard. I encourage you keep it up!"

Paul Pecorale, NYSUT vice president whose office oversees retiree issues, announced a new membership system for retiree leaders. "You asked for it so you got it!" said Pecorale explaining that starting in July, lists of new retirees will be compiled, updated and distributed to retiree leaders monthly so they can quickly and easily contact new retiree members. The new lists will be formattable for mailings; annual lists of current retirees will continue to be distributed. "It's critically important that we get new retirees involved and aware of issues."

Andy Pallotta, NYSUT executive vice president, thanked participants for their political activism and shared news of former New York state Senate Majority Leader Dean Skelos' May indictment. With less than a month left in the legislative session, he encouraged retirees to keep up the pressure. NYSUT President Karen E. Magee, Vice President Catalina Fortino and Secretary-Treasurer Martin Messner also welcomed retirees and thanked them for their support.

The three statewide retiree council directors also spoke. Loretta Donlon, ED 51 director, saluted retirees for their outstanding advocacy, terming them "fellow warriors." Calling retirees the "institutional memory" of NYSUT. Tom Murphy, ED 53 director, encouraged members to stand strong, but proceed with caution. Joan Perrini, outgoing ED 52 director, thanked participants for their support, and introduced Rosemary Catanzariti as the new ED 52 director. Catanzariti encouraged retirees to reach out to in-service members and stay abreast of what's going on in their local districts.

Other speakers included elder law attorney Steven Kramer, who spoke about NYSUT's legal service plan and Bill Friedheim and Steve Leberstein who discussed the Professional Staff Congress's Social Safety Net Working Group. The group leads statewide workshops to educate retiree and in-service members about the value of social safety net programs like Social Security and Medicare. Council presidents: Expect to receive the annual "Newly Elected Delegate/Alternate Report Form" (typically printed on blue paper) for you to complete and return to Retiree Services by June 30. Since the official ED Meeting mailing lists include only those delegates/ alternates certified for the 2015 RA, this is your opportunity to add any delegates or alternates elected since the 2015 RA as well as any retiree council presidents that are not elected delegates.

If your council has elected new delegates/alternates that you would like included in the registration process for upcoming ED meetings, please be sure to complete, sign and return the "Newly Elected Delegate/ Alternate Report Form" to Retiree Services.

Since some retiree council elections are scheduled for June and July, please return the database update form and the completed and signed "Newly Elected Delegate/Alternate Report Form" as soon as your election results are known.

Council presidents will also receive the 2015 annual request to update the Retiree Leadership Database in the same mailing.
